- Parents' Proof of Citizenship [e.g. NRIC / Passport / Entry Permit / Re-entry Permit / FIN / Certificate of Singapore Citizenship (for New Citizen)]

**2018 Direct School Admission – Secondary (DSA-Sec) Exercise**  
**- Information for Candidates Not Studying In MOE Mainstream Schools**

**Usage of the Registration Number**

1. You are required to provide your child's **Registration Number** to the DSA-Sec schools when submitting your child's DSA application.
2. During the Exercise School Preference Stage, if your child has at least one DSA offer, you will use your child's **Registration Number** and DSA-Sec PIN to login to the system to submit your school preference.

**If your child is taking PSLE**

3. Your child's PSLE results must meet the minimum requirement for an academic course [i.e. Express/Normal (Academic)/Normal (Technical)] which is offered by the school. The PSLE results will be used to determine their eligible secondary school course.
4. If your child is exempted from Compulsory Education to be home-schooled, they must fulfil the requirements of the Compulsory Education Act.

**If your child is an International Student**

5. Your child has to take part in the Admissions Exercise for International Students (AEIS) before they can be considered for admission to secondary school via DSA-Sec Exercise.
6. AEIS is conducted by MOE around September or October each year. The registration and test periods are provided below.

<b>AEIS Stages</b>	<b>Description</b>	<b>Period</b>
AEIS Registration	International Students who wish to seek admission to MOE mainstream schools have to register for AEIS.	Early July to End August
AEIS Test	AEIS consists of a centralised test on English and Mathematics that will assess the applicants' English literacy, numeracy and reasoning abilities. Admission is not guaranteed, and is subject to the applicant's performance in the test.	September or October

**Collection of DSA School Preference Form**

8. If your child is given a Confirmed Offer and/or placed on the Wait List, you will be required to collect the School Preference Form at the MOE Customer Service Centre tentatively in late October.
9. If you are unable to collect the Form in person, you may appoint a proxy to act on your behalf. The School Preference Form will contain more details, including a PIN to login, for you to submit your child's school preferences online.

**Release of DSA School Allocation Outcome**

10. Your child's DSA-Sec school allocation outcome will be emailed to you tentatively in late November.
11. If your child is successful in the DSA-Sec Exercise, they will not be allowed to transfer to another school after the release of the DSA allocation outcome. Your child is expected to honour their commitment to the posted DSA school for the duration of the programme admitted into.
